

BeYOUNion.com Game of the Week Contest

1. Eligibility

Website visitors to BeYOUNion.com/vote may participate in the voting for the BeYOUNion.com Game of the Week using a valid email. The game with the highest number of votes each week will generate \$250 contribution to the two participating school athletic departments. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All opted in email addresses wanting additional information become the property of Sponsor.

2. Sponsor

3. Agreement to Official Rules

Participation in the Contest constitutes entrants full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Schools receiving prizes are contingent upon having the largest volume of votes for the game of the week compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Contest Period

The Contest begins on August 25, 2019 at 12:00 AM CST and ends after 10 weeks on November 1st at 5:00 PM CST (the Contest Period). Votes are between the games PrepKC has selected and offered weekly on BeYOUNion.com/vote for the Game of the Week. Submissions will be accepted for the duration of the Contest through the website voting page.

5. Prize Drawing

On or about Monday, following the featuring games, the Sponsor will attempt to notify the potential winning schools via telephone or email. The schools participating in the game with the most votes wins the Game of the Week contest and both schools will be awarded the \$250 prize. If the potential winning representatives of the school cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor will select the school with the 2nd most pledges from the remaining non-winning, eligible entries.

6. Winner Notification

The potential winners will be notified by email, mail or phone. Each potential winning school will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize.

8. General Conditions

Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

9. Release and Limitations of Liability
